On January 8, 2024, NWFRW welcomes The Honorable Wayne Christian, elected in November 2016 as our 50th Texas Railroad Commissioner. Entering 2024, the Railroad Commission of Texas will celebrate 133 years of serving Texans! As the state's oldest regulatory agency, RRC has had a critical role in protecting the interests of the public. The Railroad



Commission of Texas is the state agency with primary regulatory jurisdiction over the oil and natural gas industry, pipeline transporters, natural gas and hazardous liquid pipeline industry, natural gas utilities, the LP-gas industry, critical natural gas infrastructure, and coal and uranium surface mining operations. Interestingly, since 2005, the Railroad Commission of Texas no longer has any jurisdiction or authority over railroads in Texas.

As we begin 2024, questions Commissioner Christian will address: Are we using our resources wisely? How are our energy choices impacting the environment? Can we count on the electrical grid as we move into the winter months?

#### MINUTES, December 11, 2023

**Chaplain Cindy Eschenburg** gave the invocation and led the pledges to the United States flag and the Texas flag.

President Nancy Radcliffe welcomed everyone to the last NWFRW General Meeting of 2023. She recognized the 2023 Board of Directors and thanked them for their service this year, mentioning how much work they've done and how much the club will need others from the membership to help during this important 2024 election year.

3<sup>rd</sup> VP Political Activities/Marcia Fitzpatrick introduced and welcomed elected officials, candidates, and veterans to the meeting.

1st VP Programs/Tracine Gibson introduced the special guests of the "Christmas Extravaganza," Santa and Mrs. Claus! Many members took advantage of having their pictures taken with them. Tracine also introduced a special group providing the entertainment, The Christmas Carolers, who brightened our spirits while singing many popular Christmas songs.

Have you ever thought about the importance of starting our Northwest Forest Republican Women meetings with prayer? ### Priscilla Petty Scholarship Update

On December 11, 2023, the membership of NWFRW voted to increase the amount for the Priscilla Petty Scholarship to \$1,500, effective in 2024. This annual scholarship is awarded to a female graduating from a Texas high school who has been recommended by a primary member of NWFRW. The applicant must be accepted into an accredited bachelor's degree program at a college or university in the United States. Start thinking about who you can nominate for 2024. #### **LEGISLATIVE**

Texas Empowered to Arrest Immigrants. On Monday, December 18th, Governor Abbott flew to the Brownsville border for a signing ceremony of recent immigration legislation passed to de-escalate the thousands of illegal immigrants crossing the border each day. Joining him were Senator Charles Perry, Lubbock; Joan Huffman, Houston; and Pete Flores, Burnett County. Senator Perry's Bill 4 will make it a state misdemeanor to illegally cross the border between ports of entry from Mexico into Texas. This bill will allow police to arrest those who do not have proper documentation. In turn, judges will be required to order the illegal immigrant(s) returned to Mexico. Although it is already illegal under federal law to cross the border between ports of entry, any prosecuted illegal immigrant is released through the courts under the Biden Administration as a violation of "migrant's civil rights." Under federal law, immigrants have up to a year to apply for illegal asylum. Another conflict may arise in the process of their return across the border. The data from the fiscal year 2023 shows that about 83% of the one million immigrants stopped by the Border Patrol were not Mexican citizens. Most are from Central and South America, Asia, Eastern European countries, and even Canada. According to Senator Perry, lawmakers should Biden focus getting the Administration's attention. To do that, "Texas must approve legislation that would allow police to start catching people and placing them in detention camps."

In conjunction with SB 4, Senator Joan Huffman sponsored SB 3 which would allow Abbott to use \$1.5 billion to build additional barriers along the 1,200 miles of the Texas-Mexican border. Part of this money will be used to give grants which would support municipal governments' increased costs when enforcing SB 4. Additionally, this bill allows \$40 million to pay for state troopers to patrol Colony Ridge, a growing community northwest of Houston. This controversial community has become a "magnet for illegal immigrants." According to Republican leaders, the developers flout state and local laws and target undocumented people in a growing Spanish-language community. They defend advertising that tells potential buyers they don't need a Social Security number to buy "dirt" (Texas land with paved roads and utilities). In other words, they do not have to be a United States citizen. Where little law enforcement exists, officials say the development is overrun by crime.

Will Governor Abbott Call a Fifth Special Session? Yet to be determined is whether Governor Abbott will call a fifth special session. After several tries, both the Texas Senate and House have failed to pass an Education Savings Account Bill (formerly known as the school voucher legislation). Vendors stand in wait to see if this bill becomes a reality.
