MINUTES, August 11, 2025

Call to Order. President Lauren Lothringer called the NWFRW General Meeting to order at approximately 11:30 AM on Monday, September 8, 2025, and shared the sad news of the passing of former member Nelda Napp.

Invocation and the Pledge to the American Flag was lead by Cindy Eschenburg, and the Pledge to the Texas Flag was delivered by Judge Lincoln Goodwin, both on behalf of Chaplain Tracie Anderson

Welcome. 3rd VP Anna Vierling greeted, then introduced newly elected officials, their representatives and candidates for office. She also welcomed all military veterans and members of other Republican clubs.

Meeting Program. 1st VP Programs Marcia Fitzpatrick introduced the speaker, the Honorable Sam Harless, Texas House Representative for the 126th District since January 2019 and 2025 recipient of the Effective Conservative Award. Representative Harless provided key highlights of the 89th Legislative regular and special sessions, including his support of bills related to the renovation of the George R. Brown Convention Center, first responder pensions, law enforcement pay parity, property tax relief and border security, to name a few. He concluded by announcing that he would not seek re-election when his current term concludes at the end of 2026.

Approval of the Minutes. The minutes of the NWFRW August 11, 2025, General Meeting were approved as printed in the *Potpourri* and will be filed with the secretary.

Treasurer Lisa Migl gave the Treasurer's report, and it will be filed with the minutes.

1st VP Programs Marcia Fitzpatrick reminded members of the off-cycle election on November 4, 2025, which will include 17 state propositions as well as school board trustee and water board elections. At the meeting on October 13th, Melissa Conway, Co-founder and Managing Director of Texas Election Network (TEN) will be the speaker. Former First Lady Barbara Bush said, "If more people could read, write, and comprehend, we could be much closer to solving so many other problems our country faces today." More books are needed to give to all third graders in these Title 1 schools.

This dictionary also contains the Declaration of Independence, US Constitution, biographies of all US Presidents, some third-grade math and science, and much more. In Title 1 schools, this may be the first book owned by the child and may be the only book in the home.

The second special session of the 89th legislature concluded on Sept. 4. With the unpassed legislation and recent Executive actions, it is still possible that Governor Abbott will call a third special session.

PASSED LEGISLATION:

- ➤ Congressional redistricting: House Bill 4 redrew the state's congressional maps. The new maps are expected to increase the number of Republican-held districts in the U.S. House of Representatives.
- ➤ Youth camp safety: Following deadly floods in July 2025, Senate Bill 1 and House Bill 1 updated safety regulations for youth camps, requiring updated emergency plans and stronger safety standards for camps in flood-prone areas.
- ➤ K-12 assessments: The Legislature approved an overhaul of K-12 assessments, replacing STAAR with

three shorter tests administered across the school year to provide faster feedback and reduce testing pressure.

- ➤ Women's health and safety:
- House Bill 7 (Woman and Child Protection Act): Prohibits the distribution of "abortion-inducing" drugs, including through mail or from out-of-state. It also allows individuals to sue anyone who provides or creates these drugs.
- Senate Bill 8 (Texas Women's Privacy Act): Requires sexsegregated facilities, such as bathrooms, in government buildings to be used according to the biological sex designated at birth. This bill bans transgender individuals from using facilities that align with their gender identity.

UNRESOLVED LEGISLATION:

- THC regulation: The Senate passed its version of Senate Bill 6, but the House's version stalled. After the session ended, Governor Abbott issued an executive order on Sept. 10 to call state agencies to regulate THC products and restrict people under the age of 21 from purchasing them.
- Expansion of property tax cuts: Negotiations over local spending limits and related property tax measures broke down late in the session, leaving the package unresolved.
- > Taxpayer-funded lobbying ban did not make it across the finish line.

WHAT BILLS ARE ENROLLED, but not signed by Governor Abbott?

When a bill is enrolled, both the Texas House and Senate have passed identical versions of the legislation. There are 16 bills enrolled from this special session. Governor Abbott has until Sept. 24 to either sign or veto these bills. If he does not take action on a bill, it will automatically go into law.
