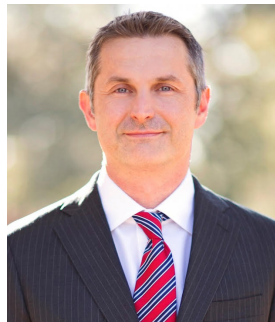

## MINUTES, January 12, 2026

**Call to Order.** President Lauren Lothringer Maywald called the NWFRW General Meeting to order at approximately 11:30 AM on Monday, January 12, 2025. She expressed condolences on behalf of the club to the family of The Honorable Jon Lindsay, former Texas Senator and HC Judge. She also reminded members of the February 12th NWFRW PAC fundraiser. Tickets were being sold at the meeting.

**Invocation** was led by Georgan Reitmeier, and the **Pledges to the American and Texas flags** were led by the Honorable Sam Harless, HD 126, on behalf of Chaplain Tracie Anderson.

**Welcome.** President Maywald introduced 2026 Executive Officer and Board Members. 3rd VP Marcia Fitzpatrick greeted, then introduced elected officials, their representatives and candidates for office. She also welcomed all military veterans and members of other Republican clubs.

**Meeting Program.** 1st VP Programs Paige Harr introduced the three candidates for HD 126, Polly Looper, Kelly Peterson, and Stan Stanart, who were participating in today's forum. She also introduced The Honorable Laryssa Korduba, HC Justice of the Peace, Precinct 4, Place 2, who served as the moderator.

## LUNCH

**Approval of the Minutes.** The minutes of the NWFRW December 9, 2025, general meeting were approved as printed in the *Potpourri* and will be filed with the secretary.

**Treasurer Amy Uribe** gave the Treasurer's report, and it will be filed with the minutes.

**PAC Treasurer Gaynell Lira** gave the PAC Treasurer's report, and it will be filed with the minutes.

**1st VP Programs Paige Harr** thanked the HD 126 candidates and Judge Korduba for their participation in today's forum. The speaker for the February general meeting will be announced in the February *Potpourri*, so be watching for the next exciting program hosted by NWFRW.

**2nd VP Membership Kathy Crosby** reported 2026 primary membership dues of \$45 and for associate members, \$30, are being accepted. She encouraged those who have not renewed as well as new members to turn in membership forms and payments as soon as possible. Being a member of NWFRW is a great way to stay informed and learn about the candidates.

**3rd VP Political Activities Marcia Fitzpatrick** shared the importance of being registered to vote by February 2nd, in order to vote in the primary elections. She also shared that February 20th is the application deadline for a mail-in ballot; early voting will be held February 17-27; and the primary election date is March 3rd.

The Primary Season is in full swing. The field is full of Republican candidates running in many races. Be sure to do your due diligence by reading, researching, and attending forums/events in order to make an informed decision. It is important to get the best Republicans elected to represent the Republican Party in order to beat the Democrats in November.

**Northwest Forest Republican Women will be sponsoring a candidates Meet-and-Greet on February 19th from 5:00-7:00 PM at Thistle Draftshop 5210 FM 2920, Spring TX 77388.** This will be a come-and-go event. Be sure to get educated and VOTE early. Keep Texas **RED** and turn Harris County **RED**. Local Precinct Conventions will be held Saturday, March 7th. They will be grouped by State Representative districts. More information will be coming about this!

**2026 is when Republicans must vote **RED** in each race up and down the ballot. Staying home or not voting all the way down the ballot is a vote for the other side.**

**SCHOLARSHIP***LaDonna MacDonald | Nicole Peters*

**Remember it's that time of the year to nominate applicants for the Priscilla Petty Scholarship!** Established in 2005 in honor of NWFRW's founding member and first president, the current amount of the scholarship is \$1,500. An applicant must be a graduating senior female from a Texas high school who will be attending a 4-year accredited university in the fall of 2026, and she must be nominated by a primary member of NWFRW.

If you know someone who would be a good candidate, please reach out to her, and if she is interested in applying, you will need to provide your nominee with an application. Since a portion of the application is your recommendation, please complete that portion before giving the application to the student. **The deadline is March 31, 2026, so all forms should be received by either LaDonna MacDonald or Nicole Peters on or before that date.** The link to the application is below and can be found on the NWFRW website. **DOWNLOAD SCHOLARSHIP APPLICATION**



The Texas Legislature is in its interim following the 89th Legislature's 2025 adjournment after regular and special sessions that delivered key Republican victories. There are several new laws that became effective January 1, 2026. SB 8 requires sheriffs in larger counties to partner with ICE via the 287(g) program for immigration checks in jails, with grants available for smaller counties. HB 149 establishes the Texas AI Council, sets transparency and consumer protection standards for AI, bans harmful uses, and promotes balanced innovation. SB 38 streamlines evictions of squatters and unauthorized occupants while preserving due process for property owners. Tax relief measures (HB 9 and others) raise the business personal property exemption to \$125,000, prohibit post-disaster tax rate increases without voter approval, and extend Research and Development credits.

The Texas Education Freedom Accounts (TEFA) school choice program begins for the 2026-27 school year with ~\$1 billion initial funding to serve 80,000–100,000 students. Open to all eligible Texas families, it prioritizes lower-income (below 500% FPL) and disabled students via strict tiers and lottery if

applications exceed capacity. Private school/provider applications opened December 2025. Family applications run February 4 to March 17, 2026, with awards notified around May 1 and funds available July 1. Amounts: up to ~\$10,000+ for private tuition, and \$2,000 for homeschooling.

A summer 2025 special session redrew congressional maps to create additional Republican-leaning districts. In December 2025, the U.S. Supreme Court granted a stay on a lower court injunction, allowing the maps to proceed for 2026 elections (no changes to state legislative districts).

**Remember to VOTE in the March 3rd primary elections! U.S. Senate incumbent John Cornyn faces challengers including Ken Paxton and Wesley Hunt. The Attorney General primary features Republicans Joan Huffman, Mayes Middleton, Aaron Reitz, and Chip Roy. Other statewide and legislative races also have competitive and open contests. Check personalized ballots and candidate details at the Texas Tribune interactive tool or your county Republican Party website. Let's turn out strong, and keep Texas RED!**
