## MINUTES, December 8, 2025

**Welcome.** 3<sup>rd</sup> VP Anna Vierling greeted, then introduced elected officials, their representatives and candidates for office. She also welcomed all military veterans and members of other Republican clubs.

**Meeting Program.** 1<sup>st</sup> VP Programs Marcia Fitzpatrick introduced professional musician Ben Miller, the organist and leader of the Praise Worship Band at Klein United Methodist Church and pianist at Two Tones Dueling Piano Bar in the Woodlands.

**Approval of the Minutes.** The minutes of the NWFRW November 11, 2025, General Meeting were approved as printed in the *Potpourri* and will be filed with the secretary.

**1<sup>st</sup> VP Programs Marcia Fitzpatrick** thanked Ben Miller for providing the meeting's entertainment. She also thanked Santa for joining the meeting and membership for bringing Teddy bears and other small stuffed animals for distribution by the Precinct 4 Constables. The January 2026 meeting will feature a forum for the three candidates running for Texas State Representative for House District 126, the position currently held by the Honorable Sam Harless. 

## LEGISLATIVE

The Texas Legislature is a bicameral body consisting of the House of Representatives (150 members) and the Senate (31 members). As of 2026, the composition remains unchanged from the 89th Legislature elected in 2024, with Republicans holding majorities in both chambers: 88-62 in the House and 20-11 in the Senate. House members serve two-year terms, while senators serve four-year staggered terms, meaning the current Senate configuration will persist through 2026. The presiding officers are Lieutenant Governor Dan Patrick (Republican) for the Senate and Speaker Dustin Burrows (Republican) for the House. Governor Greg Abbott (Republican) appoints committee chairs and influences the agenda, particularly through special sessions.

Texas holds regular legislative sessions in odd-numbered years, limited to 140 days. No regular session is scheduled for 2026; the 89th Regular Session concluded in June 2025, and the next regular session (90th) convenes on January 12, 2027. Legislative activity in 2026 would occur only during special sessions called by the governor, which are limited to 30 days and focused on specific topics. As of December 2025, no special sessions have been announced for 2026, though the governor retains authority to convene them as needed.

Pre-filing of bills for the 90th Session begins November 9, 2026, allowing lawmakers to prepare legislation in advance. Recent special sessions in 2025 addressed redistricting, border security, and education, suggesting potential carryover topics if reconvened. Budget-related matters for the 2026-2027 biennium, including a proposed \$330 billion all-funds expenditure (with \$150 billion from general revenue), were finalized in 2025 but could prompt supplemental sessions for adjustments. Broader priorities, such as property tax relief and school choice, may resurface if fiscal or policy pressures arise.

Overall, the 2025 session maintained Texas's fiscal conservatism, delivered measurable property-tax relief, and positioned the state as a leader in emerging technology regulation and creative-industry incentives while preserving Republican legislative supermajorities heading into the 2026 elections.

Governor Abbott summed it up: "Texas remains the greatest state in the nation!"
